Context update (Afar IDPs)

- According reports from the AFP 8068 are U5C and 3752 PLWthere are 27,757 registered IDPs in three locations of Aba'ala area.
- The IDPs living in open space with no shelter and other lifesaving assistance since they were displaced.
- The AFP have mobilized limited antimalaria medicine and volunteer health workers to respond the malaria outbreak.
- OCHA,UNDSS and WFP led access and security mission was conducted b/n 11th -13th January via Afar and has visited Megale woreda centre and Faro kebele.
- However the team couldn't visit the three kebeles (Tonsa, Hida, Aradu). However, Megale local authorities reported some 3,500 people are in need of assistance in Tonsa.





Context update.....

- OCHA and UNDSS conducted road access and security assessment mission on 5-6 January via Adigrat — Fatsi — Erob — Bizet -Sero- Enticho- Adwa -Edaga Arbi and Nebelet.
- Couldn't pass beyond kerseber, Erob-Dewhan but managed to pass Adigrat-Sero-Enticho-Adwa-Edagarbi-Nebelet-Hawzen.
- Movement of supplies and humanitarian staff continued to Adwa, Axum and Shire since Dec 22,2022, 14,463 MT of food and non-food items- to Central and NW zones of hard to reach areas.
- Fuel has started entering Tigray region since 10th January
- Access mission to Maitsebri on 10th January by OCHA, UNDSS and UNHCR

Food Cluster situational update as of 12 January 2023

☐ Key updates:

- Since mid-November 2022 when humanitarian food supplies resumed to enter Tigray, around 90,000 MT of food for Round 2 and Round 3 along with fuel stock has been brought into the region as of 12 January.
- Recent IDP assistance:
 - Food being dispatched to Mehoni and Maychew (Southern Zone) today (13 Jan.)
 - Partners' internal review on caseload reallocation assistance for recent IDPs (displaced from Rama, Chila, Ahsea, Adet and Egela, etc) in Adwa, Axum, Abi Adi, Adigrat and Hawzen
 - **♦** Food distributed to more than 135,000 recent IDPs in Mekelle.

Food Cluster situational update as of 12 January 2023

Key updates:

- Humanitarian access, particularly in border areas, areas off the main roads and locations requiring cross-line movements, continues to be challenging for food response. As of 12 January, some woredas remain either fully or partially inaccessible for food partners:
 - In Central Zone Adet, Adwa, Aheferom, Ahsea, Chila, Edaga Arbi, Egela, Emba Sieneti, Endafelasi, Hahayle, Naeder, Rama and Tahtay Maychew.
 - ❖ In Eastern Zone Erob, Gulo Mekeda and Zala Anbesa town.
 - In North Western Zone Adi Hageray, Dima, Laelay Koraro, Seyemti Adyabo, Tahtay Adiyabo, Tselemti, and Zana.
 - In Southern Zone Chercher and Ofla.

Food Cluster situational update as of 12 January, 2023

Key updates:

- For R1 of 2022
 - As of 10 November, JEOP dispatch (48,299 MT; 93%) + WFP dispatch (24,846.7 MT; 68%) = 73,145 MT (83% in total).
 - During early August and late October: partners assisted 4,565,263 people (88% of total planned caseload of 5.2 million people by non-governmental partners) with 72,604 MT of food in 75 woredas as of 10 November.
- **For R2 of 2022**
 - Total dispatch: 79,584 MT to 73 woredas; Total distributed: 66,995 MT to 3,948,209 people in 68 woredas.
 - ❖ JEOP dispatched 45,700 MT to 48 woredas and distributed 38,084MT of food to 2,248,919 people in 45 woredas.
 - ❖ WFP dispatched 33,884 MT to 25 woredas and distributed 28,911 MT of food to 1,699,290 people in 23 woredas, including more than 135,900 new IDPs in Mekelle.

Key Challenges (12 January, 2023)

- Unable to address the humanitarian food needs of 24% of the target population by all food partners (in 2nd Round of 2022).
- Humanitarian access, particularly in border areas, areas off the main roads and locations requiring cross-line movements, continues to be challenging for food response.
- All food partners have to continue relying on humanitarian flights to bring cash into the region while banking service, gradually resuming in the main towns, is yet fully functional. Significant amount of cash is required for partners to cover relevant costs for loading, offloading, dispatch and monitoring as well as paying previous credits.
- Together with the local authorities and communities, partners are working on re-targeting to include people who are newly displaced or experiencing secondary displacement in the caseload and identifying other most vulnerable people in need based on available vulnerability information (for instance, demographic and socio-economic data). This exercise has been very challenging due to fluid population movements, high number of displaced people, limited or non-existing local government structure, presence of multiple armed actors in some areas, and lack of documentation among IDPs.





Way Forward (12 January, 2023)

- To support partners in providing timely and adequate assistance to the most affected populations with limited resources, resuming unrestricted flow of commercial supplies into Tigray and ensuring that civil servants, having not been paid for more than 18 months, receive their salaries is crucial in addition to gradual resumption of essential services (including banking, communication and other enablers) across the region.
- Sustaining the ongoing food assistance through the most appropriate modalities, complementing it with agriculture and livelihood support in collaboration with other clusters is critical to improve food security in the region and prevent further deterioration. It is expected that food assistance may be needed at least up to next main harvest season in late 2023. Scaling up support for agricultural production, market integration and early recovery activities with provision of regular and predictable assistance is urgently needed to reduce the food gaps in Tigray.

PROCEDURES TO GET EDRMC CLEARANCE FOR THE MOVEMENT OF HUMANITARIAN CARGO WITH SUPPORT OF THE LOGISTICS CLUSTER VIA 3 ACCESSIBLE CORRIDORS: MEKELLE-SEMERA, GONDAR-SHIRE, KOMBOLCHA-MEKELLE

Convoys are not required to move humanitarian cargo. Partners can move to all areas of Tigray, from any accessible corridors, provided they have received EDRMC support letter.

The Logistics Cluster is supporting partners in the compilation of the movement needs, notifying EDRMC and compiling the information of the confirmed arrivals

To receive the EDRMC support letter: humanitarian partners are required to notify the Logistics Cluster of intended movement using the template provided in this document. Partners are also required by EDRMC to report back to the Logistics Cluster on confirmed arrivals.

Partners are accountable for their cargo and for timely notification of cargo movement.

Failure to notify EDRMC may induce complications along the Humanitarian Corridors.

ORGANISATION IS RESPONSIBLE 1) OF ENSURING TIMELY NOTIFICATION TO THE LOGISTICS CLUSTER OF THEIR INTENDED CARGO MOVEMENT, 2) OF THE SAFE ARRIVAL AT FINAL DESTINATION OF THE CARGO, AND 3) OF REPORTING BACK TO THE LOGISTICS CLUSTER ON THE CONFIRMED ARRIVAL AT FINAL DESTINATION.

Cargo Information to be submitted to Logs Cluster

The partner organisation submits the list of trucks to be included in the upcoming notification to EDRMC, following the Logistics Cluster template and before **12:00 EAT**, daily.

For Health, IT, Agriculture items: Line Ministry Support Letter to be obtained by partner and shared with Logistics Cluster.

Confirmation of Receipt

The Logistics Cluster confirms receipt of the list of partner trucks seeking EDRMC support letter.

EDRMC Notification Submission

A consolidated list of partner trucks is sent to EDRMC including all trucks intending to move.

Notifications are submitted daily at 14:00 EAT. The Support Letter is expected to be received by EDRMC on the same day.

Logistics Cluster to share back with partners the EDRMC Support Letter

Once EDRMC sends back the support letter for the notified trucks, Logistics Cluster will share the letter with all relevant partners.

Cargo Movement

No convoy movements are required, and humanitarian partners are free to move to all areas of Tigray, from any corridor and to any destination.

Confirm to Logs Cluster of cargo arrival at destination

Partner organisations are required to inform the Logistics Cluster of confirmed arrival of their cargo at destination, for reporting purposes.

FUEL

No restriction on fuel, and it can move freely. WFP BSP will continue to provide fuel upon request and on a cost-recovery basis, until availability of commercial fuel is restored in Tigray. As for the humanitarian cargo, partners moving fuel by their own means need to notify the Logistics Cluster to obtain the EDRMC support letter.

IT equipment, health and agriculture items

Relevant line ministry support letter is required. Once received, the letters should be shared with the Logistics Cluster in order to obtain EDRMC support letter.

Cash movement

As per EDRMC "operators can present their justification on outstanding transactions or magnitude of the operation upon their request. This arrangement will serve until the banking service start"

Cargo airlifts from Bole airport

Authorities at the airport have informed the Logistics Cluster that previous procedures apply (line ministry, EDRMC and NISS clearances required for cargo to enter bole airport. more information on airlift sops available on the logs cluster website)

Weekly Operational Updates

□Since 15 November, **37 partners** requested support letter for the movement of **3,137** trucks. **3,134 trucks** obtained EDRMC support letter, and **2687 trucks** with 106,035.9 MT of humanitarian supplies and 970, 436 litres of fuel have confirmed arrival via the three corridors.

□Between 29 December and 11 January, the arrival of **150 trucks** carrying **8,157 MT** of humanitarian supplies and **3 WFP fuel** tankers carrying **141,519** Litres of fuel via the Semera-Mekelle Corridor was reported.








Nutrition-Context and Requirement

- 99906 children screened, 33.4 per cent (33327children <12.5 cm MUAC or proxy GAM) and 3.14 per cent (3142 children <11.5 cm MUAC or proxy SAM).
- 21614 PLW screened, 55.4 per cent (12068 PLWs are <23cm MUAC) of acutely malnourished.
- A total of 4543 SAM children admitted for treatment and out of it 4410 children < 5 were admitted to OTP and 130 SC admissions for SAM treatment. This is the highest weekly admission in 2022.
- 50,000 carton of RUTF for January-march2023 released by UNICEF AA and expected to come to Tigray soon.
- Partners taking nitration supply and not distributing to health faculties. It is reported that supplies are at partners warehouse.
- Non availability of the health workers in health faculties created a biggest challenge for nutrition intervention as availability for supply improves.



Health Cluster Update for ECC Week 52



- In contrary to the horrific situation Partners are totally devoid of antimalarial supplies
- Needs urgent solution and direction by the ECC to avail these supplies.

- Phase one already conducted in Ten weredas with support of partners and came up with the heart teaching case stories.
- The team provide response in 35 Hfs and 91% of the health facilities reported malaria epidemic
- ▶ 64% of the catchment kebelles affected by the epidemic (total kebelle:120)
- 42,793 total malaria cases reported from Epi week 19-51,2022 from 10 weredas
- There were 206 reported severe cases and referred to hospitals: (3 P/hospitals only))
- Total deaths 39 (community:28), community deaths were clinical cases diagnosed by HEWs.
- Malaria epidemic has occurred even in non-malarious weredas like Slewa (> 3000 masl)

Case scenario 1



- During October and November, there were no anti-malaria drugs in Samre.
- The people forced to use such herbals as medicine
- They squeeze this oloe and drunk the fluid come out of I
- They drunk the aloe liquid part at fasting time.


Case scenario 2

Teamir Giday is 6-month old leaving in Lemelem Kecherwa Kebelle, Samre Wereda. During the campaign he becomes positive for malaria and SAM case on screening., his mother died when she went to Finaruwa PHCU from Woyn kebelle by traditional ambulance to give birth, on the same day his father died by flood accident when he had went from Samre to Woyn to support his wife during delivery. Finaly Teamir left with mother and father (orphan).even he might have died unless the team reached him prvide the antimalarial medicine.

• We get these heart breaking case stories from Samre nearby to mekelle You can imagine what will happen in the inaccessible and malaria hot spot wereda like T/maichew and chilla where alerts of outbreaks reported.



Eye diseases finding ...



Case scenario...

- A 7-month unvaccinated male child Presented with redness of eye, discharge (Purulent), pain and eyelid oedema
- Three months duration, Not improved with medication (Ointment)
- Took culture sample and S. Aureus isolated
- Prescribed ciprofloxacin 0.3% QID + Oral antibiotics but these medicines are not available 3/10 the area. The fate of this child is blindness.





Recommendation

- Better to distribute and apply mass treatment with Tetracycline, Ciprofloxacin and Gentamycin
- Needs mass screening of children's to conjunctivitis



Epidemic Typhus/Kelapsing Fevel Epidemic at Kelma Kebene, bechegula villages, bora wereda

An outbreak of Epidemic Typhsu has been occurring in TBoH and WHO immediately deployed to a team for Ix and response.


Of 21 identified cases, 13 (72%) were Females and 5 (28 %) Males cases.

- **11(61%)** were greater than 15yrs, **5(28%)** age group 5-14 and **2(11%)** was among the age group of <5.
- Three male deaths (o1 neonate and two >15 yrs old) All of them from the same family.
- Nine peoples has been living together. Almost all member of the families(8) were infected with Typhus/RF, one patient is still not improved..
- infestation of body louse in patients cloths and healthy individuals, poor personal hygiene and Mass sleeping
- The problem still there hence we need urgent support and involvement of all clusters specially WASH-IPC





Operational update

TWRB in collaboration with zonal offices and WASH partners has conducted a rapid WASH situation assessment & organized workshops at Abi adi, maichew & Adigrat towns to reactivate the sub-regional clusters. The following are **Key observations**

- ☐ Water stress is common in all the assessed weredas (Abiadi, Adigrat, Maichew and Mekoni new IDP centers & hosting communities.
- ☐ More than 181k IDPs in **Maichew and Mekoni** are suffering due to a lack of water and sanitation service (Latrines, showers, hand wash facilities & soap).
- Over 172K IDPs and 800K HC needs WASH assistance in **Abi adi**. & Following the peace agreement, the disengaged army relocated to this area become additional burden to provide Wash service.
- Overcrowded IDPs in Maichew, Abiadi & Adigrat are highly exposed to water-born & communicable diseases (Scabies, diarrhoea, fungal & eye infections)

But at all the assessed weredas

- ☐ The response of partners is very limited only a few are responding in clusters.
- Partners aren't reaching the remote and challenging areas They have been working along the asphalt road and near the center of the woreda.
- ☐ Partners' response on durable solutions (maintenance of damaged schemes) is limited.



Regional Emergency Coordination Center

operational update in NW & central zones

- Reports of critical shortage of safe drinking water is coming from different weredas in north western zone (Adi-daero, Adi- nebried, Adihageray, Sheraro, Endabaguna, & Tselemti. Water schemes (hand pumps, water treatment plants, pipelines are damaged & looted purposefully for the second time and still looking partner for maintenance.
- In central zone, **Axum** water supply pipeline coming from the Adwa Midmar Dum is broken on the way to Axum & by now water situation at Axum is dire.
- Destruction of water quality laboratory , limited water testing kits & consumables has affected to ensure water quality surveillance at Adwa though partial water supply service is resumed.

Recommendations

- Strengthening Zonal coordination (Participation of partners, regular update & information sharing, coordinating resources and engagement with other clusters)
- Prioritizing WASH response to IDPs, maintenance of non-functional water supply schemes and institutional WASH is vital.
- Additional WASH partners & humanitarian agencies intervention is needed at Abiy Adi and Maichew.
 Further lack of presence of CCCM limits response to IDPs in Abiy Adi and Maichew.
- Monitoring of on/off partners (unstable partners)
- High need for Water trucking to meet the current need due to new displacements.
- Chlorination of the water supply scheme is critical
- Strengthening the Capacity of woreda-level maintenance team is needed.

Key challenges

- Access: Many of the woredas are still not accessible.
 - This affects distribution and WASH maintenance work.
- Funding is very limited with WASH partners
 - No funding since October 2022.
- Supplies: Very limited and reducing every week.
 - Most supplies are related to NFIs and Very limited supplies for repairs and maintenance work.
 - Cost of EM items is high
- Response needs v/s Scale of response. Needs are high and low scale-up capacity.
 - Further, the cost of WASH response is significantly high. Water trucking and desludging cost have increased in the region.
- Technical staffing The number of staff and technical capacity is very limited among WASH partners.
 - No technical support visits noted from National offices
 - No additional staffing noted among partners
- Sustaining and capacity building at Zonal & Woreda level technical staff to ensure operations and maintenance of WSS
 - Many technical field staffs are leaving / not working as they were not supported in the last 2 years
 - The tools and equipment have been lost
 - Training / Refresher training needed
 - Lack of resources and hunger no support for survival needs
 - Lack of salary in last 18 months to Water sector staff resulting in no/limited services





Emergency Shelter & NFI Cluster Update







Contextual update

- Four ES/NFI Cluster partners are conducting damage assessment in SC-4 IDP site to identify the level
 of damage and items needed to maintain the damaged shelters.
- According DTM ETT 150 report a total of 172, 530 Ind/41867HH IDPs were displaced from North Gonder, Central, Northwestern, Waghamara, West Gonder and Western zones to different woredas of Central and Northwestern Zones of Tigray. About 38,971 HH / 165,531Ind IDPs were also turned to Asegede, Axum, Shir, Sheraro, Tahatay Adiyabo, Tahatay koraro Mai tseberi, Makelay Adiabo, seyemti Adiyabo, Tahatay Maychew and Adi Dearo from different parts of Tigray.
- The 82HH IDPs relocated from Afar Agatina to Mekelle Quiha still planned to relocate to any IDP site in Mekelle, searching for empty IDP site.
- According to EDRMC assessment report a total of 71K new arrivals were registered in Shire town
 and currently living in extreme need of shelter and NFI assistance.
- CCCM, Education and ES/NFI Clusters were discussed and proposed shelter options such as relocation of IDPs to the empty shelters, expansion of the existed IDP sites, rental support, government finished structures/private unfinished buildings, area-based approach, and as last resort collecting IDPs to 4-5 schools.

Challenges Encountered

- Access is still challenging cluster partners to distribute the ES/NFI to the needy people specially in some parts of Eastern and Southern zones.
- Movement restriction to Gulomekada and Erob weredas of eastern zone challenging to reach out the IDPs living in the areas.
- Limited ES/NFI supplies available in stock and in pipeline comparing to current demand of shelter and NFI in the region.
- No clear direction on the new shelter construction, expansion of the existed shelters and return of IDPs living in schools.

- The delay to reopen school has become a constraint to the education cluster response.
- Hold a tripartite discussion with CCCM & ESNFI/IOM to seek solution and the way forward to handling the issues of IDPs in schools in preparation for school reopening.
- Reactivated the Sub Regional coordination hubs in Maichew, Abiyi Addi, Shire, Axum &
 South Eastern zone
- Huge community demand for school reopening but teachers' livelihood remained unaddressed and a bottleneck for school reopening.

TIGRAY EDUCATION CLUSTER - Challenges Encountered

- Lack of funding to reactivate the education structure and address teachers' livelihood.
- The use of Schools as a shelter by IDPs and non education activities impacting the implementation of non-formal education.
- The absence or limited presence of education partners due to the lack of funding. For instance, no education partner presence in Adigrat while there are 16,520 (9,925 girls) school age IDPs children who seek access to education services.
- Access to areas where IDPs children access education remains challenged.
- Absence of certification of schools for UXOs clearance to ensure a safe learning space.

- 991 HH displaced from Alamata, Chercher, Gulomekeda, Irob and Zalamebesa sheltered in Mayliham and Yekatiti-11 (524 in Mayliham and 467 Yekatit-11). elementary school
 they are suffering by shortage of humanitarian assistance, (Water, NFI, Medicen, light)
- Lack of sanitary pad and soap is currently the main challenges of women and girls at reproductive age (14-49) in all IDP sites
- Partners unable to bring supplies due to prioritization for life saving items, delay on procurement and shortage of CP&GBV supplies at local market with fair price.
- In Abi Adi, UNHCR with it's Partner distributed NFIs to 2392 vulnerable HHs, and donated assorted cloth to 700 individuals,





Protection cluster update

- According to BOSEGE, risk of HIV AIDS transmission is a growing concern in the IDP sites as well as IDPs living with host community particularly in Abi Adi,& Adigrat
- Shortage of life-saving assistance i.e., food & NFI in among the IDPs that causes a major protection concern for the wellbeing of IDPs (women, children, elderly & person withdisable).
- CP-AoR partners have limited geographical coverage/inaccessible areas compared to the large need for Child Protection, therefore, Family Tracing and Reunification remained constrained.
- Limited number of active GBV partners in the region only 7 are reported this week
